HPGS Survey Findings

Professional. Relevant. Helpful.

These are the words that HPGS members use to describe their Society in the membership survey conducted in December 2007. The survey provided many insights about the membership that the Executive Board will use to build a stronger and more responsive Society. The survey was designed for three specific purposes: 1) obtain information about members' impressions about the Society; 2) gather information about members' knowledge of and participation in Society activities; and 3) pull together demographic information.

Some of the results include:

- Members want information, resources, conferences, networking, and workshops to help advance their learning for their jobs;
- While a majority of members know about the monthly meetings, just a little more than half (61%) has attended one. Those not attending would like the meetings held at a different time and/or a more convenient location.
- Nearly all (95%) members know about the biennial conference and three-fourths attended the most recent conference. Of those attending, 91% were satisfied with the event.
- The membership is aging. More than three-fourths (78%) are over age 46.
- Members believe the Web site can be improved by: providing links to other sites of interest (63%); opportunity for networking (47%), and job opportunities (53%).
- More than half (61%) of members report using the Internet for professional use several times

per day, with younger members using it more often (89%) compared to older members (54%).

- Members are highly educated. More than half (59%) have a Master's Degree, one fourth (25%) have a Bachelor's degree; and 8% have a doctoral degree.

HPGS Partners with UH for Business Plan

A team of MBA candidates from the University of Hawaii's Shidler College of Business has contracted with HPGS to produce a strategic business plan intended to address fund development and operational plans for our organization. Calling themselves the Inspired Consulting Group (ICG), they have been working with the board, our Marketing Consultant **Danielle Lum**, and members to deliver an analysis and recommendations as part of their practicum project. The final plan will be submitted in May 2008 for board review and action.

The team consists of **Joanna Amberger, Inga Fong, Ildiko Kern-Harmath, Meslissa Matsuda,** and **Sandra Riberio**. We are fortunate to have the services of the ICG, all of who come with solid work backgrounds in the business field.

Hideo and Mieko Yoshinaga Foundation Awards \$25,000 for Nursing Scholarship Endowment

Recognizing the acute shortage of nurses especially in the long-term care industry, the Hideo and Mieko Yoshinaga Foundation awarded HPGS with \$25,000 to establish a nursing scholarship program. This generous donation will be used as an endowment that will be managed by the Hawaii Community Foundation. Monica Haboush, Yoshinaga Trustee, explains: "Back in 1992 when the Foundation was started, Mieko Yoshinaga, one of the founders suggested that one of the Foundation's aims could be to advance nursing in Hawaii. Up to HPGS's proposal, the Foundation had not received a request to fund nursing in Hawaii. In Mom's memory and in gratitude for her foresight to advance an under-recognized but very important profession, the Foundation decided to fully fund HPGS's scholarship proposal." HPGS is working closely with Hawaii Community Foundation to help establish the scholarship criteria and guidelines. The scholarship will be used to assist nursing students who are pursuing future careers in elder care as registered nurses, licensed practical nurses and certified nursing aides.

\$5,000 Donation from Thomas and Elizabeth Brodhead Foundation

HPGS was the recipient of a \$5,000 gift from the Thomas and Elizabeth Brodhead Foundation. This gift will be used towards the HPGS scholarship program, which supports undergraduate and community college students pursuing studies and careers in aging. This scholarship program is

available to students from different health and social science studies. In 2007, two students received a \$500 scholarship each, and another student a \$600 scholarship to help defray their tuition fees, books and other educational expenses. Thanks to the Brodhead Foundation, HPGS will be able to award more scholarship awards to Hawaii's students and help build the State's workforce of elder care professionals.

Faces of Family Caregiving Campaign

In 2008, the Hawaii Family Caregiver Coalition will conduct a Faces of Family Caregiving Campaign to create more awareness of the needs of family caregivers, highlight community resources available to family caregivers, put a face to family caregiving, and work with them.

Each program listed below is vital to informing and educating family caregivers in Hawaii:

KHON TV2 Elderhood Project

Each Thursday morning News Anchor Kirk Matthews interviews people in the community about issues that affect the elderly and services available to them.

KGMB9 Genius of Aging Campaign

The Genius of Aging Campaign has partnered with business, non-profit, government, grass roots, and educational organizations to cover related stories, provide information and resources on air and on their website

The 2008 Family Caregiver Awareness Day and Resource Fair

It will be held on March 14, 2008 from 9:00 a.m. to 2:00 p.m. at the State Capitol. Not-for-profit organizations and community agencies who provide caregiver resources, as well as businesses that service caregivers and recipients and our sponsors will be encouraged to have an exhibit at the fair. The 2008 Aging Issues booklet will be published. More than 1,000 people are expected to attend this free event, which will focus on community, industry and the Legislature becoming more knowledgeable and proactive.

2008 Seniors Fair – September 2008

Hawaii's Senior Fair is the largest in the USA and

the ideal place to reach thousands of seniors, caregivers and family members. The Hawaii Family Caregiver Coalition will have an exhibit at all of the Senior Fairs statewide. Caregiver issues, educational materials and resources will be distributed. Participants will be able to speak with agency representatives about caregiving.

2008 Family Caregiver Recognition & Awards – November 2008.

For the second year, and in conjunction with National Family Caregiver Month, Statewide nominations will be accepted for organizations that develop and provide programs and/or services for caregiver Education, Support, or Advocacy. In addition, one family caregiver will be selected from each island to receive a family caregiver award. The honorees will be featured on KHON TV2, in press releases, and in agency newsletters.

Marketing & Publicity

The Coalition has partnered with KHON2 on their Elderhood Project and KGMB9 on their Genius of Aging Campaign and is able to promote/feature these activities on television. The 2008 Aging Issues booklet will be published in March to inform and educate the public. We will also ask our partners in the community to publicize our activities on their websites and in organizational newsletters.

*Making the Move:
Relocation Stress Syndrome in the
Elderly Population*

Her experience is in acute hospitalization, home care, long-term care, assisted living, adult day health and Alzheimer's placement. She also holds a bachelor's degree in communications and a master's degree in film and television as well as her master's in social work with a certificate in gerontology. She is a member of the medical staff at the Motion Picture and Television Fund hospital in Los Angeles, the California Geriatrics Society, and the National Association of Social Workers.

"The stress associated with relocation is so extreme that experts equate it with the stress of divorce or of a death in the family. Relocation Stress Syndrome (RSS) was recognized as an official diagnosis in 1992. What we sometimes call "transfer trauma" has particular relevance for the elderly population. As many as one million seniors currently live in facilities and senior relocation is fast becoming a specialty area of focus for professionals serving the older members of their communities. Persons transferred between long-term care institutions have a mortality risk two to four times greater than those who are not transferred. Following relocation, a senior can expect an estimated 31% decrease in his or her social network and up to a 30% chance of a hospitalization within 30 days of moving.

This program will help professionals who work in senior living learn to identify and minimize the risks associated with relocation, to address problems from a clinical standpoint and create interventions and care plans that facilitate positive outcomes. This is an energetic and passionate presentation that will appeal to anyone who works with senior relocation, hospitalization or placement. Sample scenarios, engaging exercises and creative solutions ensure that participants will leave with expanded knowledge of Relocation Stress Syndrome in the elderly and what we can do to prevent it."
