HPGS NOVEMBER WEBINAR



Terry Peacock, Senior Plan Consulting, gave a free presentation about Medicare Open Enrollment on Thursday, November 29th. Throughout the hour, Terry informed attendees about the numerous parts to Medicare, what they cover and what is not. She also talked about Medicaid, how that differs from Medicare and other financial support systems available to seniors.

Attendees learned that Medicare Open Enrollment lasts from October 15 – December 7

and is specifically geared for changes in Medicare Advantage Plans and Part D only. Depending on your situation, if you are 65 or older you have the chance to change your plans for the following year to better meet changing medical or drug needs. However, if you are satisfied with your current plan, no action is necessary. You can compare plans online at Medicare.gov or through delegate agents of insurance companies.

MAUI SURVEY

The Maui County Office on Aging (MCOA) is seeking feedback from older adults (part- or full-time Maui County residents age 55 or older) and caregivers (individuals who have in the last six months helped another with various tasks such as bathing, cooking, cleaning, laundry, rides to doctor appointments, translation, bill payments, etc.) during an online survey that will go live December 7th, through February 1, 2019, at www.mauicountyadrc.org. Caregivers, who don't have to be blood-related or living nearby (may include remote support), include an unpaid caregiver of an adult 60 or older; an unpaid caregiver of an individual 18 or older with a disability; or a guardian of a younger person, such as a grandparent or relative raising grandchildren (hanai or another arrangement). Paper surveys are also available by calling MCOA. All responses are anonymous.

The results will help Maui County plan on aging for 2019-2023, which is a public document that outlines how the agency intends to meet identified goals and activities in the next four years with the funding it receives. The plan is also shaped by demographic information, community needs assessments and growing trends throughout Maui County. The plan also addresses issues described in the Older Americans Act with regard to assisting those who are in the most need, socially and financially.

The survey data will be reported by a MCOA plan produced in spring 2019. For more information about the surveys, the plan on aging or the MCOA, contact James Mariano at 808-270-7349.
