#### Message from the President: Coming Up! HPGS Biennial Conference in October

Mention the acronymn HPGS, and most people in Hawaii will think of our bienniel conferences. The 16<sup>th</sup> Biennial HPGS Conference is Monday and Tuesday, October 18<sup>th</sup> and 19<sup>th</sup>. Two years of careful planning and lots of work have gone into the preparation, thanks especially to the

Conference **Co-Chairs Eme Kim and Tony Wong**. Special thanks also to **Sarah Yuan and Michael Cheang**, who co-chaired the Program Committee. Many others worked on the Planning Committee and Subcommittees. It has taken a genuine team effort to put this conference together and I am so grateful for all of your efforts. We believe that this year's conference will be especially exciting.

The theme of this year's conference is "Preparing for the Aging Tsunami: Hawaii and Pacific Rim Perspectives." Our conference aims to inspire us to make positive responses to the challenges ahead as our population ages. The plenary on Monday morning will provide information about new developments in Japan and Korea from Dr. Takeo Ogawa and Dr. Sung-Nam Cho, gerontology experts in their respective countries. Japan and Korea are experiencing rapid aging and have developed new policies and programs to address the challenges. The plenary session on Tuesday will focus on the directions of our national policies, featuring John Rother from AARP, and Dr. Joshua Wiener will also inform us about innovative policies and programs by other states. During the afternoon on both days, there are sessions providing an opportunity to reflect upon and discuss the implications for Hawaii of the information provided in the morning. Tuesday afternoon will feature a session where candidates for governor will be asked about their positions in regard to aging

#### Social Security Proposes Legislation to End Furloughs of Federally Paid State Disability Workers

Michael J. Astrue, Commissioner of Social Security, today announced that the agency is submitting legislation to Congress that would prohibit states, without the Commissioner's prior authorization, from reducing the number of state personnel who make disability determinations for Social Security or the hours they work below the amount the agency authorizes.

"It is long past time that states end these unconscionable furloughs and hiring freezes that needlessly harm citizens with disabilities," Commissioner Astrue said. "States realize no fiscal savings whatsoever from these actions and this legislation would prevent needless delays in the disability determination process. I am grateful for the President's support and urge Congress to move quickly to help us make this provision the law of the land."

More than a dozen states have implemented furloughs and hiring freezes that affect the federally paid state workers who make disability determinations for Social Security. The state agencies that employ these workers in their disability determination service (DDS) components receive 100 percent of their funding from the Federal government. Accordingly, states do not save any money by imposing furloughs and hiring freezes on federally funded employees. Rather, they slow benefits to some of the most vulnerable citizens - for example, furloughs in California in fiscal year 2010 delayed payment of over \$11 million in benefits to more than 40,000 citizens with disabilities. State-imposed furloughs and hiring freezes also reduce state income tax revenue and increase unemployment in the state.

"The members of Local 1000 have always believed that furloughing federally funded positions doesn't make economic sense and that has been proven in California during these past 18 months that Governor Schwarzenegger has imposed furloughs on state employees," Yvonne Walker, President of Service Employees International Union Local 1000 said. "I applaud Social Security for initiating legislation that would prevent further bad economic policy from going forward. This provision will not only help DDS workers, but the claimants who rely on the services our members provide."

"We commend the Commissioner for his forceful and dedicated leadership in taking this bold action," said Susan X. Smith, President of the National Association of Disability Examiners (NADE). "Our members are witness to the impact the current economic recession has had for disabled citizens and we are working hard to meet the dramatic increase in claims for benefits. These furloughs further compound the problems faced by disabled citizens by creating unnecessary delays in the processing of their claims. NADE urges quick action with regards to this legislative proposal."

#### **Social Security Travels Too**

Have you ever considered a visit abroad? Or maybe you're planning to live overseas for an extended period of time. Whether you're outside the country for a week or a decade, you may be unaware of how to reach Social Security in the event that you need to conduct business with us while you're away. Fortunately, in most corners of the world you can get help from a federal benefit officer or other trained personnel.

The Department of State embassies and American consulates abroad have personnel who are specially trained to provide a full range of Social Security services, including taking applications for all types of benefits, processing applications for new or replacement Social Security cards, and an array of other Social Security business.

Americans in American Samoa, British Virgin Islands, Canada, and Puerto Rico may obtain services directly from Social Security field offices located there. In other territories or countries, contact your local embassy or consulate to find out which office to visit for your Social Security needs.

But before visiting or moving abroad, remember that the most convenient office may be in your own home. Social Security's website is a valuable resource for information. There are a number of services and forms offered to people living outside the United States on our international operations site. You can find it at *www.socialsecurity.gov/foreign*. While you're online, you can read more about our international services. Another helpful reference on moving out of the country is the online publication Your

If you don't have a computer or prefer to do business over the phone, you're always welcome to call Social Security at **1-800-772-1213 (TTY 1-800-325-0778)**. If you are in a foreign country, you will need to pay for the call because we do not offer toll-free service for calls from outside the U.S. If you call, please do so during normal business hours for the U.S. Eastern Standard time.

If you're leaving the United States for any period of time, don't think you'll have to leave Social Security behind too. Social Security will travel with you.
