#### Hawaii's Senior Medicare Patrol Receives National Award

The Administration on Aging and the Centers for Medicare & Medicaid Services presented the "Innovation in Program Capacity Building and Outreach Award" to the Hawaii Senior Medicare Patrol ("SMP Hawaii") at the 2011 SMP National Conference, held at the Omni Shoreham Hotel in Washington, D.C., August 9-11, 2011. The award recognized the innovative statewide volunteer recruitment and educational outreach campaign that SMP Hawaii conducted under the SMP Capacity Building Grant. Through a combination of radio, TV, and print ads, the Hawaii SMP increased its volunteer enrollment by almost 75%, in addition to reaching limited English proficient populations in Hawaii to alert them to the danger of Medicare identity theft. Four of 55 total SMP projects in the U.S., Guam, Puerto Rico, and the Virgin Islands received the award. The conference featured a display of SMP educational outreach products, including SMP Hawaii's recently-released durable medical equipment fraud brochure.

The Senior Medicare Patrol is a program established by federal law in 1997 and administered by the U.S. Administration on Aging. The goal of the SMP program is to recruit and train retired professionals to educate their communities to detect and report health care fraud and abuse and to help persons with Medicare and Medicaid to correct billing errors.

In Hawaii, the SMP is based in the State Executive Office on Aging. Dr. Wes Lum, Director of the Executive Office on Aging, Adele Ching, SMP Hawaii Coordinator, and Laurel Paleka, SMP Hawaii Assistant attended the SMP National Conference. While there, they were briefed on health care fraud schemes, law enforcement actions, and SMP outreach initiatives under the theme: "2011 SMP National Conference—Leading the Grassroots Fight Against Fraud."

The Centurian Project involves contacting Social Security Administration centenarians 100 years of age and older to verify their continued survival, identify possible payee issues; ensure their continued eligibility for benefits and to make sure they are being paid the correct amount of benefits. The San Francisco Region has a web-based application through which they they track Centenarians and document the result of the interviews on the website. The SF web based application was expanded nationally. All regions will now use this website to reach out to centenarians in their region and conduct interviews. Our island has 20 centenarians. Hilo SSA representatives will be contacting our beneficiaries to conduct the interviews in the near future.

# NATIONAL NEWS

#### All Social Security Offices to Begin Closing 30 Minutes Early

Effective August 15, 2011, Social Security offices in the local area will be open to the public Monday through Friday from 8:30 a.m. to 3:00 p.m. - a reduction of 30 minutes each weekday.

While agency employees will continue to work their regular hours, this shorter public window will allow them to complete face-to-face service with the visiting public without incurring the cost of overtime. Congress provided Social Security with nearly \$1 billion less than the President requested for the budget this fiscal year, which makes it impossible for the agency to provide the amount of overtime needed to handle service to the public as we have in the past.

Most Social Security services do not require a visit to an office. For example, anyone wishing to apply for benefits, sign up for direct deposit, replace a Medicare card, obtain a proof of income letter or inform us of a change of address or telephone number may do so at <u>www.socialsecurity.gov</u> or by dialing our toll-free number, **1-800-772-1213**. People who are deaf or hard of hearing may call our TTY number, **1-800-325-0778**.

#### Franciscan Vistas Ewa Provides Affordable Housing and Wellness for Hawaii's Older Adults

Franciscan Vistas Ewa, a new \$40 million senior living community in historic Ewa Villages, celebrated its grand opening on July 12, providing a new housing and wellness solution for Hawaii's older adults.

The 149-unit community, located at 91-1471 Miula Street, addresses two of the greatest challenges facing Hawaii's rapidly growing older adult population: affordable housing and access to health and wellness services. It provides an affordable alternative for older adults living on limited, fixed incomes.

Construction began in January 2010 and the sixth and final apartment building was completed in May

2011. As of mid-August, there were 13 remaining units available for rent.

"With 128 years of health care experience in Hawaii, the Franciscan Sisters recognized the need for a healthy community that fosters an active lifestyle to help people remain independent for as long as possible," said Pamela Witty-Oakland, Chief Administrator of St. Francis Residential Care Community.

Unlike any other affordable independent living community, Franciscan Vistas Ewa has a wellness component as an added benefit to encourage seniors to stay active and healthy through the promotion of socialization. Fitness and educational programs are offered to assist residents with sustaining better health so that they may prolong their stay in their own home. Generally, such amenities are available in independent living communities for those who are more affluent.

"Franciscan Vistas Ewa is a model community where affordable housing meets wellness with condo-style living accommodations," Witty-Oakland added.

Rental units are reserved for tenants 62 and older with household incomes no more than 60 percent of Honolulu's median annual income, or \$41,700 for a single person or \$47,640 for a family of two. Initial monthly rents are \$745 for 530-square-foot onebedroom units and \$885 for 750-square-foot twobedroom units. All individuals in the household must be 62 years and older. #### SMP Hawaii Releases Durable Medical Equipment Fraud Brochure

SMP Hawaii, Hawaii's Senior Medicare Patrol Project released in July 2011 a brochure about durable medical equipment (DME) fraud. It is based on a brochure written by the Michigan Medicare/Medicaid Assistance (MMAP). SMP Hawaii volunteers Marv and Michele Paularena revised the MMAP brochure, taking into consideration comments about the MMAP brochure that SMP Hawaii solicited from social workers and discharge planners at Hawaii hospitals and skilled nursing facilities. The brochure briefly describes DME fraud, how to protect against DME fraud, and to whom to report potential fraud. Financial support for this project came from the Senior Medicare Patrol Project Grant from the U.S. Administration on Aging and a contribution from HMSA.
