

Local Construction Company, Nan Inc., Gives \$1 Million to St. Francis Healthcare Foundation of Hawaii

Nan Inc., one of Hawaii's largest construction companies, presented a check for \$1 million to St. Francis Healthcare Foundation of Hawaii. The gift, which was made at the Foundation's holiday reception, will be used to support the 119-bed Clarence T.C. Ching Skilled Nursing Facility on the St. Francis Liliha campus.

This is the second major donation earmarked for the skilled nursing facility. The Clarence T.C. Ching Foundation gave a lead gift of \$4 million when St. Francis announced its plan to open a skilled nursing facility in late May of this year. The total cost for the skilled nursing

facility plus commercial kitchen, surrounding courtyard and wellness center is projected to be \$20 million.

Patrick Shin, owner of Nan, Inc., said his mother, Yun Sun Shin, was on dialysis for several years and came to St. Francis for treatment twice a week. When she was hospitalized, he visited her every day, sometimes two to three times a day. During that time, he came to know St. Francis well and was grateful for the care his mother received. His mother passed away in 2008.

"St. Francis has a special place in my heart," said Shin, who moved to Hawaii in 1989. "I hope this contribution can help St. Francis in some way."

Architects Hawaii Ltd. is the architect, and Allied Builders System is the general contractor. Design work is being finalized and renovation will begin when appropriate permits are obtained.

The project will consist of converting nearly 50,000 square feet of space on the third, fourth and fifth floors of the Sullivan Building, one of the existing buildings on the Liliha site previously used for the hospital. It will feature private and semi-private rooms, which will be different from most nursing homes in Hawaii that have mainly wards for four people or more. One of the floors is targeted to open in the spring of 2014.

Families who visit their loved ones at the new Liliha long-term care facility will be able to enjoy a beautiful and comfortable home-like atmosphere and residents will have an expansive activity room with panoramic views of the Honolulu skyline.

"We are extremely pleased that Nan Inc. has also embraced our vision for the skilled nursing facility," said Sister William Marie Eleniki, OSF, St. Francis Healthcare Foundation of Hawaii, who oversees all fund development efforts. "This very generous gift was Patrick's way of giving back to the community to show his appreciation. It's always heartwarming to hear how St. Francis is making a difference in people's lives," she added. The St. Francis Liliha campus already offers a multitude of services for seniors provided by The Cancer Center of Hawaii (cancer treatment, radiation therapy), Clinical Laboratories (laboratory), Liberty Dialysis (dialysis services), Pharmacare (pharmacy services), Hawaii Endoscopy Center (outpatient endoscopy), in addition to an 800-stall parking garage. Hawaii Diagnostic Radiology Services, formerly known as Yeoh & Muranaka, which provides outpatient imaging and radiology, opened its new location in July of this year.

Founded in 1990, Nan Inc. has grown from a small business to one of Hawaii's largest general contractors. Eric Dishman, of Intel Corporation (Portland, OR) will be in Honolulu as a special guest speaker on April 10-11, 2014. Mr. Dishman will be engaging with Hawaii's healthcare, gerontology, academia, IT and business community in a series of public dialogues. His discussions will

focus on developing information and communication technologies across the continuum of health care from hospital to home; the needs of aging population and use of technology to promote health and wellness; research and product development; as well as highlight economic opportunities in in-home and health care technologies.

Changes in Certain Social Security Services

Beginning August 2014, we will no longer issue Social Security number printouts in our field offices. Individuals who need proof of their Social Security number and cannot find their card, will need to apply for a replacement card.

In addition, beginning October 2014, our field offices will stop providing benefit verification letters, except in emergency situations. Benefit verifications are available online, and can be obtained anytime by registering for a *my Social Security* account located at:

Imagine 2030... what will Hawaii look like as we are getting older as a society? There will be 369,000 adults aged 65 and over—150% of its current size—whom will constitute 23% of the total population (currently 17%). The number of people aged 85 and over will double to 59,000. Most adults prefer to stay in their home of choice as they age. What will a community supportive of purposeful aging in place look like? How do we get there?

The 2014 Hawaii Pacific Gerontological Society Conference invites you to share your best work in practice or research in the Concurrent Sessions. We are interested in presentations that address the conference theme: *Imagine 2030...Mobilizing our Communities Across Generations*. Presentation proposals will be accepted in three broad topical areas:

Improving Health, such as healthy living, disease prevention, healthcare delivery systems, caregiving, and health technology.

Strengthening Economies, such as economic security, work and leisure activities, business, innovation, education and training, and health and long term care financing.

Enabling Community, such as family support, intergenerational exchange, volunteerism, community well-being, policy and advocacy, and a sustainable environment.

The conference will feature keynote speakers, plenary sessions, and concurrent sessions of speaker, panel and workshop presentations. The HPGS Conference is intended for elder care practitioners in the health and human service fields; businesses, government agencies, non-profits, and faith-based organizations serving older adults; applied researchers; students; and advocates. It will be held at Hyatt Regency Waikiki Beach Resort and Spa, Honolulu, from September 29–30, 2014.

Proposal Submission Guidelines and Review Process

The Presentations Committee invites prospective conference participants to submit a presentation proposal that addresses the conference theme— *Imagine 2030...Mobilizing Our Communities Across Generations*. Selected presentations will be scheduled for the Concurrent Sessions. Presentations may be practice or research focused. We welcome proposals from all disciplines and professions. Presentation contents must be new and highly relevant to the majority of our conference participants.

Each presenter is limited to <u>two</u> proposals, and may not be the single or lead presenter in more than one proposal. Once a proposal is accepted, <u>all</u> of the presenters must register and pay conference fees in advance to confirm participation and be included in the printed program of the Conference.

The Presentations Committee will review all completed proposals received online by the deadline. Notifications of acceptance will be emailed to the lead presenter by early June.

Prepare Your Proposal

All information submitted should be proofed for spelling and other errors. We highly recommend that you prepare the required information (see below) in a Word document, then copy and paste the information online. Incomplete online applications cannot be saved.

- 1. Title of presentation
- 2. Presentation type: Select one-
 - **Speaker presentation**, 45 minutes, involves a 30-minute presentation, followed by questions and answers.
 - Workshop presentation, 75 minutes, involves substantial interaction with the audience.
 - **Panel presentation**, 75 minutes, involves 3 to 5 presenters (for instance, a chair or facilitator plus 2 to 4 panelists). At least 10 minutes must be left for audience interaction.
- 3. Topical area: Select one-
 - Improving Health
 - Strengthening Economies
 - Enabling Community
- 4. **Abstract:** Describe the presentation in **200-250** words. When appropriate, please provide the following information: Objectives, relevancy, research or program implemented, key findings or outcomes, and conclusion or lessons learned. Accepted abstracts will be reproduced in the conference program exactly as submitted. Please check carefully before submitting.
- 5. **Learning Objectives**: Provide 2 to 3 learning objectives for your presentation, with at least one of the objectives being related to the conference theme.
- 6. **Keywords**: List 1 to 6 keywords that describe the subject matter of your presentation. E.g., financing long-term care, family caregiving, informational resources, healthy aging, etc.
- 7. **Lead/Organizing Presenter**: Name, highest graduate or professional degree obtained, email address, phone, mailing address, affiliated organization, position/job title.
- 8. **Other presenters (up to four):** Name, highest graduate or professional degree, email address, affiliated organization.
