HOW TO DECLUTTER FOR 2022

Here are some tips and tricks from professional organizations that will help you make some serious progress in 2022:

1. **Set a schedule.** Set aside a designated day and time to declutter. Be realistic on how long you think it will take and make the time.
2. **Prep for donations.** Call one of the nonprofit organizations and schedule a donation pick up. This will help you get started with one box at a time. If it helps, schedule a pick up once a month to help encourage you to have donations ready every month.
3. **A box for every room.** Place one or two boxes in every room before you start and don't forget a trash bag. That way, as you enter the room, you can get right to decluttering. Turn on some music - the Oldies station has great songs!
4. **Pick a room.** When you pick a room, set the time for 30 minutes to an hour, and make FAST decisions. Toss trash, remove duplicates, and don't keep anything you haven't used in years.
5. **Stay focused.** To stay streamlined and focused in a room, walk into the front door, turn your head to the right and start with what you're looking at, move around the perimeter of the room until you've successfully made it back to the front door! This will help prevent you from bouncing all over the room and wasting time.

GIFT OF SOUND - FREE HEARING AID PROGRAM

The Rotary Club of Honolulu is teaming with Miracle Ear Foundation's Gift of Sound™ program, which provides free hearing aids to those that qualify. The application fee is \$150, which includes a hearing assessment, hearing aid fittings and follow-up adjustments. While supplies last, the Rotary Club of Honolulu will assist those who can not afford the \$150 application fee through its Can You Hear Us Now? program.

The Gift of Sound program aims to address that issue. Applicants for assistance must complete the Gift of Sound application form (www.miracle-ear.com/miracle-ear-foundation/eligibility) and must show: less than \$25,750 annual gross income and evidence establishing the inability to pay the Gift of Sound application fee.

"A HOUSE DIVIDED" BY KATHY WYATT, RN, MSN, MBA, LNHA

Having been separated from family and friends for the past two years, the Holiday trip to the mainland this year gave me a lot of food for thought. The whole Covid issue, vaccination issues, and varying opinions in the family have opened my eyes to why there is a division, not just in my family, but I understand the angst everywhere.

Two of my family have underlying conditions, so they have to be extra careful. Three of my family members had to get the vaccine in order to keep their jobs, but are not planning on having the booster (and one of them had Covid – the lack of smell and taste version). One of us had a serious case of Covid and got the vaccine after recovery. Three of us got it because we're intelligent and knew we didn't want to get sick. And then there are the two who are not going to get the vaccine, no matter what, and even though they have a small child. Because of them, our family Christmas get togethers had to be fragmented because the folks with underlying conditions couldn't be with the two knuckle heads that won't get vaccinated. And since mask wearing in certain areas on the mainland isn't required, we had to take all of that into consideration, including family members that don't wear them!

Being a health care worker, all of this nonsense just made me crazy!! I didn't want to make waves during the holiday, since we hadn't been together for over two years, but I have to say that I am shocked about the ridiculous reasons that were given for not wearing masks or getting the vaccine and booster shots.

Topic: Hawai'i Long Term Care Program

The Long-Term Care Ombudsman (LTCO) program was established by federal and state statutes.

The LTCO identifies, investigates, and resolves complaints that are made by, or on behalf of residents, and related to action, inaction, or decisions that may adversely affect the health, safety, welfare, and rights of residents of long-term licensed care facilities such as nursing homes, adult residential care homes, assisted living facilities, and other long-term care settings.

PANEL SPEAKER: JOHN McDERMOTT

JOHN HAS BEEN THE STATE LONG-TERM CARE OMBUDSMAN FOR HAWAII SINCE 1998. HE SERVED AS THE DIRECTOR OF SOCIAL SERVICES FOR SEVERAL NURSING HOMES ON OAHU, CO-AUTHORED THE SURROGATE DECISION MAKING LAW, AND CONTRIBUTED TO THE GOVERNOR'S BLUE-RIBBON PANEL WHICH WORKED ON IMPROVING AND REPLACING THAT LAW WITH THE UNIFORM HEALTH CARE DECISIONS ACT. ORIGINALLY FROM LONG ISLAND, McDERMOTT CAME TO HAWAII IN 1985. HE WAS A GRADUATE OF THE UNIVERSITY OF NOTRE DAME (1980) EARNING A BACHELOR'S DEGREE IN AMERICAN STUDIES AND PRE-LAW AND RECEIVED HIS MASTERS IN DIVINITY FROM THE JESUIT SCHOOL OF THEOLOGY AT BERKELEY (1985). IN 1989, McDERMOTT LATER RECEIVED HIS SECOND MASTERS IN SOCIAL WORK AT THE UNIVERSITY OF HAWAII. PRIOR TO HIS INVOLVEMENT WITH THE ELDERLY, McDERMOTT WORKED FOR CATHOLIC CHARITIES, SERVICES TO FAMILIES, AND OVERSAW THE INTERSTATE COMPACT ON THE PLACEMENT OF CHILDREN. HE WAS ALSO EMPLOYED AS THE LIVE-IN COUNSELOR FOR THE BOYS HOME AT HALE KIPA.
