# HPGS NA LIMA KOKUA AWARDEES

Since 1986, the HPGS biennial conference awarded individuals, organizations or companies with their *Na Lima Kokua Awards*. The 2023 conference continued the tradition with six categories - Business, Community/Arts, Community Service, Government, Research/Teaching, and the Tony Lenzer Scholar - and all were recognized in the conference program and at the Thursday lunch.



Below are short excerpts from the program:

**Business** - *<u>Fred Collins</u>, an Advanced Planning Advisor and the Seminar Speaker for Valley of the Temples. His nominator wrote, "The ease of working with Fred and the painless process when the funeral plan is needed, makes the loss of a loved one bearable."* 

**Communications/Arts** - <u>KupunaWiki</u> was formed in 2015 to be Hawaii's Senior Resources for information in many needed areas for kupuna. They wrote, "We share the HPGS goal of enhancing the general well-being of our Kupuna."

**Government** - Elected in 2018 to represent areas around Ala Moana, Senator <u>Sharon Moriwaki</u> is currently the co-convener of the legislative Kupuna Caucus. She wrote, "Let's continue our work together on policies and programs to enhance the well-being of our kupuna!"

**Research/Teaching** - A publication by <u>Jenny Lee</u> entitled "Development of Older Adult Food Insecurity Index to Access Food Insecurity of Older Adults" was completed in 2022. Her nominator wrote, "The evidence-based model solidified facts that impact food insecurity among older adults across all the sphere of the SEM."

**Tony Lenzer Scholar** - A scholarship of \$2,000 was given to two deserving individuals:

"<u>Nargis Sultana</u> is working toward her PhD in Public Health with a research interest in the health and well-being of older adults living in urban areas." She also had a poster presentation.

"As a third-year PhD student in the Social Welfare program at UH-Manoa, <u>Miliama</u> <u>Ku`uipo Iloilo</u> is interested in the field of gerontology." Miliama also did a poster presentation.

# Are We There Yet?: Recruiting, Sustaining, and Mentoring Hawai'i's Geriatric Workforce

Ensuring a geriatric workforce is critical to the health and well-being of our kupuna in Hawai'i. The "Great Resignation" during the pandemic deepened the pre-pandemic work shortages in health care as workers left for higher paying positions. Moreover, the Healthcare Association of Hawaii's recent report underscored this with 17% unfilled positions of their membership organization, reflecting an increase from 2019's ten percent.

This practitioner panel will examine innovative approaches to recruit, sustain, and mentor health care workers in assisted living and institutional care from the perspectives of nursing and social work in different care setting. Presentations will include changing the work culture through paraprofessional engagement, addressing students' perceptions of working with older adults, continuous mentoring of students to newcomers throughout their careers, and different ways to engage students in careers in aging.



# **Announcing Zoom Dementia Series Workshop**

for Caregivers, Friends, Providers and Advocates of Persons Living with Memory Loss or Dementia



*James H. Pietsch, JD* joined the William S. Richardson School of Law after first having served on active duty in the US Army Medical Service Corps and the Judge Advocate General's Corps and subsequently serving as the directing attorney of the Honolulu Elder Law Unit of the Legal Aid Society of Hawai'i (LASH). He is a professor at the law school, here he teaches Law, Aging and Medicine, Elder Law Clinic, Advanced Health Law (Experiential), and, in association with the Nancy Atmospera-Walch School of Nursing, Health Law: Bioethics. He also holds an appointment at the John A. Burns School of Medicine where he specializes in teaching issues at the intersection of law, aging, healthcare, bioethics, and psychiatry. In addition to his teaching duties, he is the director of the University of Hawai'i Elder Law Program (UHELP), which provides limited direct civil legal services at the law school to socially and economically needy older persons as well as their caregivers.

Note: Neither this session nor the handbook discussed are intended to provide legal advice or to serve as a substitute for professional legal advice.

## Essential Legal Planning Issues for Dementia Presented During a Class with the William S. Richardson School of Law Elder Law Clinic Wednesday, September 20, 2023, 10-11:30am Hawaii time

- It is wise for adults to have a plan in place in the event of death or incapacity, especially for those who may be starting to experience memory loss or a decline in thinking skills as can be seen in dementia.
- Planning for death and incapacity, especially for those diagnosed with dementia, usually involves the consideration of such essential legal and related documents such as wills, durable powers of attorney for legal and financial matters, advance health care directives, including durable powers of attorney for health care and individual instructions for health care, plus for many, provider orders for life-sustaining treatment and living trusts.
- A diagnosis of dementia does not necessarily indicate a current lack of capacity to execute essential documents legal and related documents, so it is important to seek professional legal and health care advice early on.
- The levels of capacity necessary to understand and to execute various legal documents vary and it is important to seek the assistance of a qualified attorney to provide counsel, advice, and assistance.
- Legal Documents and related forms are often complicated so it may be beneficial to look over some samples commonly used in Hawaii found in the handbook highlighted in this presentation.
