Our first General Membership Meeting held in January was incredibly informative and prepared us to better understand the new legislative session in full swing at the Capitol. Our next General Membership Meeting is set for May 16, 2024. Our featured speaker will be Board member Courtney-Paige Dimaggio who is a Public Health Nurse on the Island of Molokai.

If you don't know about the great work of our Public Health Nurses in assisting (and at times rescuing) some of our vulnerable kupuna, please plan to join us on Zoom. A Zoom link will be available in the coming months.

Ron Shimabuku, Director of Public Policy and Advocacy of our local chapter of the Alzheimer's Association, has been hard at work initiating and advocating for a new Silver Alert system currently being considered at the Legislature. The Silver Alert system would create a way for families or friends of lost or missing kupuna to notify authorities and the public of the emergency. It has the potential to speed up their rescue by increasing public awareness. You can track the progress of 3 separate bills – SB 2305, SB2486 and HB 1774 – addressing this by going to capitol.hawaii.gov.

We so appreciate your continuing membership with HPGS and the support it offers to our collective efforts at increasing public awareness of information, resources and issues affecting our kupuna. We are completely member supported and run by a dedicated team of community members who volunteer their time to create support for the scholarships we offer and the educational conference we organize and run every two years. ## HPGS GENERAL MEMBERSHIP MEETING

HPGS President Laurie Adamshick welcomed, via Zoom, a number of members to the first general membership meeting of the year. Sherry Goya, HPGS Executive Director, inducted the 2024 HPGS Board officers and three new directors.

Rick Tabor, HPGS past-president and chair of the HPGS Program Committee introduced Virginia Beck, who is with the State Capitol's Public Access Room (PAR). It was noted that the PAR is not in all capitols across the nation so Hawaii is very unique. Virginia had an excellent PowerPoint presentation on "Your Voice: Participating at the Hawaii State Legislature." **The HPGS General Membership Meeting was taped and is on www.hpgs.org**. The PAR is located on the 4th floor of the capitol, in Room 401. Their phone number is 808-587-0478 and website is Irb.hawaii.gov/par. The room has work space available for the public. Virginia said that the legislative session opened Wednesday, January 17th, with 76 lawmakers at the capitol. She said that the capitol website (capitol.hawaii.gov) has a wealth of information, including who your senator or representative is. Virginia encourages the public to get involved.

A legislator will have to draft the bill that will be introduced at the start of the regular session. H.B. is a house bill, S.B. is a senate one and they are numbered. To follow a bill, go to the legislature's website (capitol.hawaii.gov) and enter the bill number in the search box at the top of the page. To find bills you're interested in, click on the "Reports and Lists" box on the homepage, and then select a report title. Or use the "Subject Search" on that page to search the bill titles, description and keywords for a word or phrase. You can register an email with the legislative website so you can receive hearing notices on any of the bills you're interested in.

The PowerPoint presentation showed the "Life of a Bill" - that it must pass three readings on the floor of each chamber to pass out of the legislature; but is also passed to one or more committees to be heard. If a bill does get scheduled for a hearing, testimonies are welcome from the public, executive departments, interest groups, lobbyists. After testimonies are heard, the committee can pass the bill without changes or vote to pass with changes or defer bill, and the bill may die in the committee. In a nutshell, they start to go through the committee process, go back to the floor for a second vote, to another committee if needed, then back to the floor, then they cross-over and do it all in the other chamber. If both chambers agree on the wording, it can go to the governor before the end of session. He can then sign it into law, allow it to become law without signature, or veto it (thus rejecting it, and it won't become law unless the legislature overrides it). The governor's deadlines take us until July 11, and that's when we'll finally know what laws result from the 2024 legislative session.

HPGS Director **Rick Tabor** wants you to know that so far in January 2024, Hawaii COVID-19 data reveals an 8.4% weekly average positivity rate and 109 daily average cases statewide, accompanied by six new deaths and an average of 68 hospitalizations, including three patients in ICU.
