# PRESIDENT'S MESSAGE

The deluge of rain we were hit with last week was quite a reminder that we are now in rainy season. Hopefully your home didn't suffer and you managed to stay dry. With the power out and our to-do lists hampered, it also offered us a reminder to slow down, reflect and appreciate.

As you are probably aware, the Hawaii State Legislature reconvened on January 15 last month to begin its 2025 session. The following day we got an introduction to the top five bills supported by the Kupuna Caucus from Audrey Suga-Nakagawa, Director of Advocacy at AARP Hawaii, at our online General Membership Meeting (you can view the recording of her presentation on our website at https://hpgs.org/events/.)

To assist you in following these bills, they are:

- Relating to establishing a Caregiver Tax Credit
   HB701 & SB879
- Relating to the state Rent Supplement Program for Kupuna HB703 & SB878
- Relating to Medicaid funding for in-home services
   HB702 & SB877
- Relating to expanding eligibility for SNAP benefits and food pantries HB704 & SB881
- Relating to outreach to underserved for Medi-Medi benefits HB705 & SB880
- There are other bills related to kupuna that you may also be interested in. They are:
  - Relating to establishing a Kupuna Home Equity Conversion Mortgage program HB1306 & SB843
    - Relating to health insurance coverage for hearing aids
       SB1494

As members of HPGS, many of whom work to provide services to help support our kupuna, we should all be aware of these bills and offer our support of those we believe will make a positive difference. The Legislative Reference Bureau has downloadable instructions on how to track the bills you are interested in here: <u>https://lrb.hawaii.gov/par/wp content/uploads/sites/2/2022/11/Measure-Tracking.pdf</u>. Once you have determined which bills you want to support, Audrey provided very helpful downloadable guides of how to create an account and submit testimony, either written or on Zoom (again, see <u>https://hpgs.org/events/</u>). We hope you will get involved this year and will find these resources helpful in doing so.

# HPGS GENERAL MEMBERSHIP MEETING

A big Mahalo goes out to Audrey Suga-Nakagawa for her presentation on behalf of AARP Hawaii regarding the bills being presented to this year's legislature. She said that a Kupuna Caucus package of five bills were offered to the legislature listed below:



- Caregiver Tax Credit
- Increased Medicaid Funding for In-Home Services
- Enhance senior housing program targeting 62+ and are homeless/risk for homelessness
- Expanding eligibility for SNAP benefits and food pantries
- Med-Medi Project Outreach to underserved populations for Medicare, Medicaid, Medicare savings program, Extra Help, etc.

Other bills that the legislature will be looking at include paid family leave, increase in Medicaid reimbursement for in-house provider and care homes, establish the use of a standard cognitive screening tool to be administered to all patients at their annual wellness visit, Hawaii retirement savings program, and a Parkinson Registry for outreach and prevention.

Audrey said to get involved, you can testify in hearings (written or oral, in-person or Zoom) by knowing the bill number, offer your name with position (support, oppose or comment only), and give reasons for your position. Contact the Committee chair to share your support via a phone call or email, and share stories with the media to get your bill noticed.
